

A PICTURE OF IMPACT

Meet Jayde*—a resilient, determined young woman and a graduate of Omaha Public Schools. In May of 2025, Jayde walked across the stage with her classmates, an incredible milestone

made even more meaningful by the path she took to get there.

Just a year and a half prior, Jayde experienced a traumatic event. The aftermath left her struggling, both emotionally and academically. She stopped attending her mainstream school and was failing all her classes. **It was clear that Jayde needed more than the traditional educational path could offer.**

Recognizing this, Andrea Kemp (Jayde's CASA Volunteer Advocate) and the CASA Volunteer Coordinator worked persistently for her to enroll in a school that could better meet her emotional and academic needs. **With the right environment and support, she began to thrive.** Jayde was able to get caught up with her coursework and graduated on time.

Jayne is naturally reserved and initially declined to take senior photos, but then she shared that she

wanted to step outside her comfort zone and take part in the tradition. Andrea was there every step of the way, even picking her up from school to ensure she was ready. When Jayde needed a new outfit for pictures, Andrea didn't hesitate.

That small act of care made a big difference. Jayde was glowing with confidence and pride during the shoot, which was generously donated by Dave Uhlig of PhotoOmaha. The photos turned out beautifully, but more importantly, Jayde said it was "the best day." Her joy and pride in herself were unmistakable and were a powerful reminder of why CASA does this work.

Jayne's journey is a testament to the power of advocacy, community, and believing in a young person's potential—even when they can't yet see it themselves. We are so proud of Jayde and can't wait to see what she does next!

AMPLIFY CHANGE

When Tyler Blaser accepted his CASA case in 2025, he stepped into the life of Anthony*. Anthony was a teenager facing profound instability. This young person had experienced multiple foster home placements, parental relinquishment, and the emotional weight of depression and anxiety. By the time Tyler met him, the teen rarely left his room and often withdrew from those around him.

From the beginning, Tyler showed unwavering patience and commitment. **Each month, he invited Anthony to go out to eat—offering a simple outing as an opportunity to build trust.** Each time, the teen said yes, only to retreat back into his room when Tyler arrived. Instead of expressing frustration, Tyler adapted. He sat with him, talked with him, and remained a steady, judgment-free presence.

After months of quiet persistence, something shifted. Anthony finally agreed to join Tyler for lunch. He picked a local sandwich shop, and for the first time, the two shared a meal outside the home. It was a small moment with enormous meaning: a step toward connection and confidence.

Tyler's advocacy also included amplifying the youth's voice in court.

In a multidisciplinary team meeting concerning abuse that Anthony had endured, they discussed the teen's mental health needs and identified a potential therapist. Tyler immediately reached out to the therapist, and they were able to meet the very next day. Since then, the teen has begun leaving his room more often, taking his medication consistently,

and engaging in daily routines he had previously struggled with.

Thanks to Tyler's persistence, compassion, and advocacy, this young person is beginning to reclaim stability, hope, and a sense of self.





